MINUTES OF REGULAR BOARD MEETING
October 13, 1977 Chicago, Illinois

All Board Members were present.

Opinions and Orders were adopted by a vote of 5-0 in these cases:
##75-472, Western Properties; 76-323, Hinsdale; 77-153, Derby Meadows; 77-169, Sanitary District of Dekalb; 76-74, Illinois Power; 77-97, Cook Construction; 77-215, Presbyterian Home; 77-218, Decatur.

An Opinion and Order was adopted in #76-150, Kankakee by a vote of 4-0, Mr. Young abstained.

An Opinion was adopted in R75-9 et al, Carbon Monoxide and a proposed Order for publication and comment by a vote of 4-1, Mr. Werner dissented.

A final Opinion and Order was adopted in R76-11, Lake Sangchris by a vote of 5-0.

Motion for stay in ##74-171 and 74-193, Bulk Terminals was denied by a vote of 4-1, Mr. Werner dissented. Mr. Goodman will prepare an Order.

Motion to reconsider in #75-218, Epperson et al was denied by a vote of 5-0. Dr. Satchell will prepare an Order.

Motion to vacate in #75-492, Highland was denied by a vote of 4-1, Mr. Werner dissented. Mr. Dumelle will prepare an Order.

An Order regarding interlocutory appeal was adopted in #76-80, Allaert by a vote of 5-0. Mr. Young will prepare the Order.

Motion for continuance in #76-184, Waste Mgt. was granted by a vote of 5-0. Mr. Dumelle will prepare the Order.

Motion to reopen in #76-114, Broverman et al was denied by a vote of 5-0, Mr. Young concurred. Dr. Satchell will prepare an Order.

An Interim Order was adopted in #77-153, Derby Meadows regarding a motion for modification by a vote of 5-0. Mr. Young will prepare the Order.

Motion for decision without hearing was granted by a vote of 5-0 in #77-177, Olin. Mr. Goodman will prepare the Order.

Motion for extension of time to file and answer in #77-187, Mt. Vernon was granted by a vote of 5-0. Mr. Young will prepare the Order.

Motion to amend in #77-188, Burrows was granted by a vote of 5-0. Mr. Dumelle will prepare the Order.

A hearing was authorized in #77-202, Maple Hill due to the conditional nature of a waiver by a vote of 5-0. Mr. Young will prepare the Order.

An Order was adopted regarding a motion to restrict in #77-204, C.A. Hemphill by a vote of 5-0. Mr. Young will prepare the Order.

Motion to withdraw motion to consolidate in #77-207, Winfield was granted by a vote of 5-0. No formal Order was entered.

Motion for extension of time was granted in #77-203, Allied by a vote of 5-0. Mr. Dumelle will prepare an Order.

Motion to reconsider in ##77-219 and 76-6, Tarkowski was denied by a vote of 5-0. Mr. Goodman will prepare an Order.

Orders requesting that transcripts be filed were entered in these cases by a vote of 5-0; ##75-497, Oregon; 77-26 and 77-30, Carbon-dale. Mr. Goodman will prepare the Orders.

The Board voted 5-0 to cancel the meeting scheduled for October 27, 1977.

Earthline, accepted for hearing and motions held to November 10; 77-253, Hemphill, hearing authorized; 77-255, Peru, dismissed, Order by Mr. Dumelle; 77-256, Cairo, dismissed, Order by Mr. Dumelle; 77-257, Dept. of Transportation, Mr. Dumelle authorized to sign; 77-261, Triem Industrial, additional information requested, Order by Mr. Dumelle; 77-262, EPA v. Elgin National Bank, hearing mandatory; 77-264, Interpace, held for an Agency recommendation; 77-265, Crane Construction, held for an Agency recommendation; 77-266, Village of Arthur, held for an Agency recommendation; 77-267, Hemphill, hearing authorized and ordered consolidated with #77-253.

A petition for amendment to the Water Pollution Regulations was filed under R73-11,-12 by the Illinois EPA. The petition was authorized for publication and comment by a vote of 5-0. Mr. Dumelle will prepare an Order.

An amended proposal filed under R77-14, Solid Waste Regulations Amendments was authorized for hearing and publication by a vote of 5-0.

An administrative session was held with Ms. Wiley.

All matters not disposed of as listed were ordered held to November 10, 1977 for consideration.
