MINUTES OF REGULAR BOARD MEETING JULY 10, 1997 CHICAGO, ILLINOIS - 10:30 A.M.

After calling the meeting to order, Chairman Manning welcomed members of the public and staff to the meeting, and introduced and welcomed the Board's new summer employee, David O'Dowd. Thereafter, the Clerk was asked for a roll call, and all Board Members answered present except G. Tanner Girard who was on vacation.

Minutes of the June 19, 1997 Board Meeting were approved by a vote of 5-0. Chairman Manning abstained.

In R97-12(B), Tiered Approach to Corrective Action (T.A.C.O.) 35 Ill. Adm. Code 742, a Proposed Rule, First Notice, Opinion and Order was adopted by a vote of 6-0. (McF)(JY)

In R97-13, Emissions Reduction Market System Adoption of 35 Ill. Adm. Code 205 and Amendments to Ill. Adm. Code 106, a Proposed Rule, First Notice, Opinion and Order was adopted by a vote of 6-0. **(JY)(McF)(KMH)**




