An Order dismissing the proceedings in #86-13, C. Groot Automatic Disposal, was adopted by a vote of 7-0. (JD)

An Opinion and Order were adopted in #86-37, Blake Water Corporation, by a vote of 6-1. Mr. Meyer dissented and Dr. Marlin concurred. (WN)

Motion to amend by J. Anderson passed by a vote of 5-2 with J. Anderson, R. Flemal, J. Dumelle, J. Marlin and W. Nega for it and B. Forcade and J. Theodore Meyer against. An Order was then adopted in R84-30, East Peoria Site-Specific, by a vote of 6-1. J. Theodore Meyer dissented and B. Forcade concurred. (JA)
