**MINUTES OF REGULAR BOARD MEETING
DECEMBER 18, 1986 CHICAGO, ILLINOIS**

All Board Members were present.

Board Member B. Forcade moved a draft Opinion and Order in #84-125, Clairmont Trucking. Motion to amend by J. Anderson and seconded by J. Dumelle failed to carry by a vote of 3-2 with J. Anderson, J. Dumelle and J. Marlin for it and B. Forcade and R. Flemal against it. J. Theodore Meyer abstained. An Opinion and Order were then adopted by a vote of 5-1. Mr. Meyer dissented. (BF)

A Supplemental Order was adopted in #84-161, L&S Industries, by a vote of 5-1. Mr. Meyer dissented. (JD)

An Opinion and Order were adopted in #85-173, Majestic Wood Carving, by a vote of 6-0. (JD)

An Interim Order was adopted in #85-219, City of Watseka, by a vote of 6-0. (JD)

An Adopted Rule, Final Order, Opinion and Order were adopted in R84-42, Pathological Incineration, by a vote of 6-0. (BF)

Motion to Stay Final Order was granted in #82-101, Browning-Ferris, by a vote of 6-0. (JD)

Motion for leave to file motion to dismiss and supporting memorandum in #85-136, Navem Patel, was granted by a vote of 5-1. Mr. Meyer dissented. (BF)

Board Member B. Forcade moved a draft Order in #86-10, Bravo-Ernst. Motion to amend by J. Anderson failed to carry by a vote of 3-3. An Order reaffirming the Board's December 5, 1986 Order dismissing the motion for reconsideration, was then adopted by a vote of 6-0. (BF)


