## MINUTES OF SPECIAL BOARD MEETING JANUARY 26, 1987 CHICAGO, ILLINOIS

Meeting convened at  $3:00\ \text{p.m.}$  as per call. All six members were present.

PCB 86-3, Oglesby CSO was held over for possible decision on February 5, 1987.

A motion to amend PCB 86-139, IDOT Corps of Engineers by Dr. Marlin, seconded by Chairman Dumelle carried on a 5-1 vote with Mr. Forcade dissenting. The proceeding was then reassigned to Chairman Dumelle and placed on the February 5, 1987 agenda for possible decision.

A motion to amend PCB 86-159, Joliet Sand and Gravel, by Chairman Dumelle, seconded by Mr. Forcade, lost on a 2-4 vote with only J. Dumelle and B. Forcade voting for it. The Order by J. Anderson then passed 5-1 with J. Theodore Meyer dissenting and B. Forcade and J. Dumelle concurring.

An Order in PCB 87-4, Duo-Fast granting an extension to February 6, 1987 was approved 6-0. Mr. Forcade will do the Order.

The Resolution, RES 87-1 in R77-4, Airport Noise, was adopted 5-0 with J. Theodore Meyer present and not voting. (JM)

A motion to amend R82-36, Procedural Rules was carried 4-1 with B. Forcade dissenting and J. Dumelle abstaining. The proceeding was reassigned to J. Theodore Meyer and adopted 6-0 with B. Forcade and J. Dumelle concurring.

The meeting was adjourned at 4:40 p.m.
