## ILLINOIS POLLUTION CONTROL BOARD NOTICE OF HEARING

The Illinois Pollution Control Board gives notice of public hearing regarding rule changes proposed by the Sierra Club, Natural Resources Defense Council, Environmental Defense Fund, Respiratory Health Association, Chicago Environmental Justice Network, and Center for Neighborhood Technology on June 27, 2024: Proposed Clean Car and Truck Standards: Proposed 35 Ill. Adm. Code 242, R24-17. Interested persons are invited to attend the hearings or to submit written comments. The proposed amendment, if adopted, may ultimately result in submission to the USEPA of an amendment to Illinois' state implementation plan (SIP). Section 110(a)(2) of the Federal Clean Air Act (42 U.S.C. 15410(a)(2) (2023)). The Public Hearing will be held on March 10, 2025, March 11, 2025, and March 12, 2025, beginning at 9:00 AM by VIDEO CONFERENCE at the Michael A. Bilandic Building, 160 N. LaSalle Street, Room N505, Chicago, Illinois AND the Illinois Pollution Control Board, Springfield Office, 2520 W. Iles Ave., Rooms 1C and 1D, Springfield, Illinois. On March 11, 2025, from 4 p.m. to 6 p.m. time is set aside for public comment by VIDEO CONFERENCE.
