

7. In line 1447, delete "(l)(l)" and add "(l)(1)" (changing the second lowercase L to numeral 1).
8. In line 1470, strike the period and add "; and".
9. In line 1495, delete "I" and add "1".
10. In line 1628, delete "No<sub>x</sub>" and add "NO<sub>x</sub>".
11. After lines 1795 and 1796, in the tables, delete the period following "cold-air" four times, twice per table.
12. In line 1976, after "D)", add the heading "Diesel Engines" followed by a new line.
13. In lines 1976, add the subsection label "i" before "Before".

14. In line 1978, add :  
"ii) On and after July 1, 2025, 660 ppmv (corrected to 15% O<sub>2</sub> on a dry basis) for diesel engines other than those constructed on and after July 1, 2025;".

24. Below line 2506, in the line for "j", add "of" after "hour".
25. In lines 2606, 2608, and 2745, change the lowercase letter "l" in the citation to the numeral "1".
26. In line 2972, add "and Petrochemical Facilities" after "Refineries".
27. Below line 2984, restore "0025" in the first column.
28. Below line 2984, change the periods in the rightmost column to commas.
29. In line 2971, delete "Emission" and add "Emissions".
30. In line 2979, change the capital letter "O" in the facility ID to the numeral "0".
31. After line 2984, delete "pp".
32. After line 2984, in the second row from the bottom, change "l 08" to "108", deleting the space and changing the lowercase letter l to the numeral 1.
