

HEARING OFFICER ORDER

On March 20, 2025, all parties appeared for a telephonic status conference. Counsel for petitioner reported that the matter is proceeding according to the Twelfth Status Report filed January 17, 2025. A related petition was filed and was accepted by the Board. INEOS Joliet v. Illinois Environmental Protection Agency PCB 23-135 (August 17, 2023). It is noted that when PCB 23-135 is resolved, this PCB 16-24 matter will also be resolved. The parties await the Board's decision and/or directive.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on May 15, 2025, at 1:15 p.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




