**Answer: No. Only squirrels and cats cause the dog to bark.**

  - b. To avoid your dog from excessive barking, how do you keep things interesting for your dog? Do you provide plenty of chew toys for your dog to play with? Raw bones, toys, chew ropes, etc.? Provide documentation.

- d. Dogs are territorial and don't take kindly to other critters invading their space, such as roaming bands of feral cats, racoons, squirrels, etc. How do you resolve your dog from barking and annoying the neighbors? What steps (doggie door, muzzles, electronic collars, landscape) have you taken to eliminate excessive barking behavior during the day that will disturb the neighbors?
- e. What stimulation do you have available in your yard to keep your dog occupied outside to avoid or limit barking?
- f. Common causes of dog barking include: dislikes being left alone, frustration, guarding instinct, attention seeking, frightened, boredom, or excitement, etc. What is the reason your dog is barking? Do you provide daily exercise? Please explain.
- g. Do you isolate your dog in our backyard with no human interaction? This practice can lead to dog barking. Please explain.

**Answer:**

- a. **Yes, the dog is provided with basic health and welfare along with adequate food, water, shelter, yard space, and companionship.**  
**Yes, the dog is kept in a fenced-in yard.**
- b. **I do not leave the dog outside alone and I bring him in when he barks at critters.**
- c. **The dog loves to fetch tennis balls.**
- d. **The dog is barking because of cats and squirrels. I provide exercise by taking him to the dog park.**
- e. **I do not leave the dog alone outside or isolated and I am usually home with the dog on a daily basis.**

10. Do you prevent your dog from negatively impacting other people, animals, and the environment by allowing your dog to constantly bark? Please explain why or why not.

**Answer: Yes, I do not leave my dog alone and I take him inside the house if he barks.**

11. Give a detailed statement of the facts as to how you argue that the noise pollution (music, honking of car horns aimed at the complainant when passing by her, dog barking at complainant) took place after **May 01, 2020, Cease and Desist** letter Mr. Egan received to include any facts and documents upon which you intend to rely upon in support of any defense.

**Answer: I have never once driven past the complainant and blown my horn.**  
**Objection as to the form of the question as it is unclear, vague and calls for a narrative answer.**

12. Please identify any specific triggers that cause your dog to bark (i.e. objects, sounds, specific noises, animals, people, being left alone, etc.).

**Answer: Squirrels, cats, and raccoons usually cause him to bark.**

13. Please describe in detail the circumstances under which your dog barks. Include, but not limited to:

- a. Time of day? Day or Night?
- b. Frequency of dog barking?
- c. Duration? Daily or Weekly basis?
- d. Apparent cause of the barking?
- e. Other circumstances.

**Answer:**

- a. The dog has been known to bark day or night.**
- b. When stimulated by cats or squirrels.**
- c. The dog has never barked all day or all week.**
- d. As indicated above, the dog's barking is a result of cats and squirrels.**
- e. N/A Objection.**

14. Have you received any prior complaints or warning, formal or informal, regarding your dog barking or behaviors from neighbors, animal control, or any other individuals or entities? If so, please state the date of each complaint, the name of the complaining party, and the substance of the complaint. Please provide documentation.

**Answer: Other than Ms. Andrushko I have never received any prior complaints or warnings regarding the dog barking.**

15. If you received any prior complaints, please describe in detail any actions you took in response to those complaints.

**Answer: Does Not Apply.**

16. Have you made the statement to anyone that "you wanted advice about how to deal with a bad neighbor?" Have you taken action against your neighbor by using the dog to disturb the peace and enjoyment of a neighbor property to force anyone to move by allowing your dog to continuously bark and disturb the peace? Please explain your statement.

**Answer: I don't remember making that statement. I have never taken action against a neighbor by using the dog to disturb the peace.**

17. What is your motivation for allowing your dog to bark? Please explain.

**Answer: Objection. Vague and irrelevant.**

18. Do you find your barking dog is excessive. Why or why not? Please explain.

**Answer: No. Like every other dog in the County it barks from time to time.**

19. State where you have communicated with the complainant about the barking, and if so describe those communications.

**Answer: I don't recall communications with the complainant about the dog barking.**

20. Do you dispute the complainant's allegations regarding the barking? If so, state the basis for your denial.

**Answer: I don't dispute that the dog barks from time to time. No one else has ever complained about it.**

### **III. Preventative Action / Noise Abatement :**

21. Do you take any measures to prevent or control your dog barking? If so, please describe in detail all such measures and when they were implemented.

**Answer: I do not leave the dog alone outside and I take the dog inside if he barks.  
I have also put up fences to block the dog from seeing into the alley and Ms. Andrusko's yard within the last month or so.**

22. Noise Abatement Order:

Order: January 6, 2025 Order IPCB, Mr. Egan suggested noise remediation device installed on his property and have not met your obligation. Ms. Andrushko was informed, with a photo provided, of the "tarp" that would stand 5'10" installed on Respondent's property.

Order: February 20, 2025, Summary Judgement was denied, and still no fence was installed.

Order: March 6, 2025 status meeting resulted in no fence installation.

Order: March 27, 2025 status meeting resulted in no fence installation.

Order: April 17, 2025 status meeting resulted in no fence installation.

a. What date was 3-foot privacy device installed?

- b. Why was the original “tarp” measuring 5’10” privacy device not installed and instead a 3-foot vinyl lattice with holes/perforation?
- c. Does the 3-foot vinyl lattice with holes/perforations device mitigate the dog barking behavior? The Complainant’s wood fence picket (vertical boards) spaces contracted over time due to weatherization and the holes in the vinyl lattice allows the dog to see through the fence pickets as well as over.

**Answer:**

- a. **April 18 – 19, 2025.**
- b. **I friend of mine tried the same fence and he said the wind beat it up and tore the grommets out of the ground.**
- c. **Yes, the 3-foot vinyl lattice with holes/perforations device does mitigate the dog’s barking behavior.**

23. Do you correct the dog barking behavior immediately by training your dog? Please explain why or why not/

**Answer: I stop the dog from barking by taking the dog inside when he barks.**

24. Do you monitor your dog to assess the reason your dog is barking to take appropriate action for noise abatement? Please explain why or why not.

**Answer: I am always with the dog and I take him inside if he is agitated by squirrels or cats.**

25. Identify any surveillance systems, sound monitoring devices, or other means used to monitor noise on your property to assist with correcting the dog barking noise level and to the appropriate levels.

**Answer: None.**

26. Do you dispute that the barking of your dog has caused a disturbance to Ms. Andrushko? If so, please state all the reasons for your denial?

**Answer: Objection. Calls for speculation, is irrelevant and vague.**

27. Describe your understanding of local noise or nuisance ordinances related to dog barking.

**Answer: Objection. More appropriately answered in a deposition, is irrelevant and vague.**




28. Do you have any video or audio recordings relevant to the complainant (i.e. footage of the dog's behavior or evidence refuting the claim)? If so, describe.


