The industrial user must notify the POTW; the Director, Waste Management Division, USEPA Region 5, 230 South Dearborn Street, Chicago, Illinois 60604; and the Manager, Division of Land Pollution Control, Illinois Environmental Protection Agency, at the address of the Illinois EPA's headquarters as designated on the Illinois EPA's website 1021 North Grand Avenue East, P.O. Box 19276, Springfield, Illinois 62794-9276, in writing of any discharge into the POTW of a substance, which, if otherwise disposed of, would be a hazardous waste under 35 Ill. Adm. Code 721. Such notification must include the name of the hazardous waste as set forth in 35 Ill. Adm. Code 721, the USEPA

216 hazardous waste number, and the type of discharge (continuous, batch, or 217 other). If the industrial user discharges more than 100 kilograms of such waste per calendar month to the POTW, the notification must also contain 218 219 the following information to the extent such information is known and 220 readily available to the industrial user: 221 222 A) An identification of the hazardous constituents contained in the 223 wastes; 224 225 B) An estimation of the mass and concentration of such constituents 226 in the waste stream discharged during that calendar month; and 227 228 C) An estimation of the mass of constituents in the waste stream 229 expected to be discharged during the following 12 months. 230 231 2) Time for Notification. All notifications required under subsection (a)(1) 232 must take place within 180 days after April 27, 1992. Industrial users who 233 commence discharging after April 27, 1992, must provide the notification 234 no later than 180 days after the discharge of the listed or characteristic 235 hazardous waste. 236 237 Frequency for Notification. Any notification required under subsection 3) 238 (a)(1) need be submitted only once for each hazardous waste discharged. 239 However, notifications of changed discharges must be submitted under 240 Section 310.613. 241 242 4) Exception for Notification Under Other Provisions. The notification 243 requirement of subsection (a)(1) does not apply to pollutants already 244 reported under the self-monitoring requirements of Sections 310.602, 245 310.604, and 310.605. 246 Exemption to Reporting Requirement. An industrial user is exempt from the 247 b) 248 requirements of subsection (a)(1) during a calendar month in which the industrial 249 user discharges no more than 15 kilograms of hazardous wastes, unless the wastes are acute hazardous wastes specified in 35 Ill. Adm. Code 721.130(d) and 250 721.133(e). Discharge of more than 15 kilograms of non-acute hazardous wastes 251 252 in a calendar month, or of any quantity of acute hazardous wastes, as specified in 35 Ill. Adm. Code 721.130(d) and 721.133(e), requires a one-time notification. 253 254 Subsequent months during which the industrial user discharges more than such 255 quantities of any hazardous waste do not require additional notification. 256 257 Newly Listed Hazardous Wastes. In the case of any new regulations under c) 258 section 3001 of the federal RCRA (42 U.S.C. 6921) identifying additional

259		characteristics of hazardous waste or listing any additional substance as a
260		hazardous waste, the industrial user must notify the POTW; USEPA Region 5,
261		Waste Management Division; and the Agency, Division of Land Pollution
262		Control of the discharge of such substance, pursuant to subsection (a)(1), within
263		90 days of the effective date of those regulations.
264		
265	d)	Required Certification. In the case of any notification made under this Section,
266		the industrial user must certify that it has a program in place to reduce the volume
267		and toxicity of hazardous wastes generated to the degree it has determined to be
268		economically practical.
