**AMENDED HEARING OFFICER ORDER**

On August 25, 2025, all parties participated in a telephonic status conference. Initially discussions centered on whether the respondent's dog continues to bark. Complainant stated that "it barks at 7:00 a.m. when respondent lets it out, but she is not there." Complainant stated that she can hear the dog bark inside respondent's house but that is not an issue. Complainant then, when pressed, said that the dog is out sometimes in the day when she is there, and it bothers her.

It appears that the participation in the Chicago Conflict Resolution program is over. It appears the parties could not reach a consensus on training the dog and other issues.

After discussing a possible stipulation and proposal for settlement or proceeding to hearing, complainant insists on proceeding to hearing. To that end, complainant clarified her "Fourth Motion to Compel"<sup>1</sup> and referencing respondent's May 29, 2025, answer, seeks only to have the following ruled upon as found on page 2 of her unpaginated motion: 3 (g); 3 (o); 5; 9 (a); 9 (b); 9 (c); 9 (d); 9 (e); 9 (f); 9 (g); 11; 13 (b); 13 (c); 17; 26; 27. **Respondent to file his response to complainant's motion to compel by September 12, 2025.** I will rule on complainant's motion prior to the next status conference.

Prior to the next status conference, complainant was directed to comprise a list of exhibits she intends to offer at hearing. Respondent's response time will be addressed at the next status conference. Respondent was questioned whether he had any outstanding motions to be ruled upon. Respondent stated that he only wants the list of witnesses and exhibits complainant intends to produce at hearing.


The parties or their legal representatives are directed to participate in an agreed upon telephonic status conference with the hearing officer on October 9, 2025, at 11:00 a.m. The telephonic status conference must be initiated by the complainant by calling the number below, but each party is nonetheless responsible for its own appearance. 
