Notice of Pertition by CITGO Petroleum Corporation for an Adjusted Standard before the Illinois Pollution Control Board

On September 10, 2025, CITGO Petroleum Corporation ("CITGO") filed a petition for an adjusted standard (docket number AS 2026-001) with the Illinois Pollution Control Board ("Board"). CITGO is seeking an adjusted standard for its petroleum refinery located near Lemont at 135th Street and New Avenue in DuPage Township, Will Courty, Illinois. The adjusted standard is sought from 35 Ill. Adm. Code 216,121 due to the inability of select fuel combustion emission sources to comply with the standard during startup and shutdown. The adjusted standard is also sought as a result of amendments to 35 Ill. Adm. Code Parl 201 and removal of startup, malfunction, and break-down ("SMB") relief provisions from Parl 201. CITGO is seeking an adjusted standard in the form of an alternative emission limitation ("AEL") in lieu of the carbon monoxide ("CO") standard in 35 Ill. Adm. Code 216,121. Section 216,121 requires that a person must not cause or allow the emission of CO into the atmosphere from any fuel combustion emission sources with could heat input greater than 2.9 MW (10 mmbhu/hr) to exceed 200 ppm, corrected to 50 percent excess air.

The refinery produces petroleum-based fuel products, including several grades of gasoline, diesel, jet fuel, and high-quality gasoline, diesel, chert distillate fuels, and hydrogen productions currently seven fuel combustion emission sources (process heaters and boilers) would be subject to the adjusted standard, if adopted. These fuel combustion emission sources (process heaters and boilers) would be subject to the adjusted standard, if adopted. These fuel combustion emissions resures care various processes at the plant, including steam production, crude distillation, and hydrogen production. The removal of the SMB provisions in Parl 201 prevent CITGO for availing itself of the relief already obtained in its permit and from seeking similar relief in the tuture. The reques

relief already obtained in its permit and from seeking similar relief in the future. The requested adjusted standard incorporates provisions from federal regulations applicable to boilers and process healers that are applicable during periods of startup and shutdown. The proposed adjusted standard would apply only to fuel combustion emission sources at the refinery with actual heat input greater than 10 mmbtu/hr and that are equipped with a continuous emissions monitoring system for CO and oxygen. CITGO's proposed adjusted standard is as follows:

1. Pursuant to Section 28.1 of the Environmental Protection Act ("Act") (415 ILCS 5/28.1), the Board grants CIT-GO Petroleum Corporation ("CITGO") and its successors an adjusted standard from 35 III. Adm. Code 216.121, effective as of the date of this order. The adjusted standard applies to the emissions of carbon monoxide ("CO") into the atmosphere from fuel combustion emission sources with actual heat input greater than 10 mmbtu/hr subject to 35 III. Adm. Code Section 216.121 and equipped with continuous emissions monitoring systems ("CEMS") for CO and oxygen ("O2") at the petroleum refinery located near Lemont Illinois, at 13.5th Street & New Avenue, Durage Township, Will County, Illinois (collectively, the "Affected Units").

Township, Will County, Illinois (collectively, the "Allected Units").

2. During periods of startup and shutdown of the Affected Units, CIT6O and its successors must comply with either the standard in 35 III. Adm. Code 216.121 or the requirements applicable to tuel combustion emission sources during startup and shutdown in 40 CFR 63.7550(a)(3) and (f), 40 CFR 63.7555(5)(e), 40 CFR 63.7555(b), and 40 CFR 63.7555(d)(9)-(12) as ta those Affected Units.

3. If electing to comply with the requirements in 40 CFR subport DDDDD referenced in Paragraph 2 above during startup and shutdown of the Affected Units, the CO standard in 35 III. Adm. Code 216.121 does not apply.

4. The definitions of "startup," "shutdown," and "useful thermal energy" in 40 CFR 63.7575 apply to this adjusted standard.

Any person may cause a public hearing to be held in the above-described adjusted standard proceeding by filing a hearing request with the Illinois Pollution Control Board within 21 days after the date of the publication of this notice. The hearing request should indicate the docket number for the adjusted standard proceeding, as found in this notice. The hearing request must be mailled to the Cleft, Illinois Pollution Control Board, 100 W. Randolph Street, Illinois Pollution Control Board, 100 W.
