RULEMAKINGS

<u>R24-17</u>	<u>Proposed Clean Car and Truck Standards: New 35 Ill. Adm. Code 242 (Air)</u> – The Board granted the Movants’ motion for extension of time and motion for leave to file their motion for reconsideration of the Board’s November 7, 2024 denial of motions to dismiss. The Board also granted the motion for reconsideration and, on reconsideration, affirmed its denial of the motions to dismiss. In addition, the Board stayed this rulemaking until the resolution of <i>State of California v. United States</i>, No. 4:25-cv-04966-HSG (N.D. Cal., filed June 12, 2025) or until the Board orders otherwise. The Board ordered the Movants and the Rule Proponents to file written status updates on this litigation every six months, beginning on March 5, 2026. The Board also allowed other participants to file status updates on the same schedule.	5-0 roll call vote

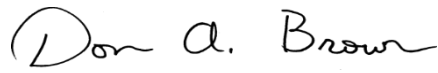
