**RAIN CII CARBON LLC’S STATUS REPORT AND
UNOPPOSED MOTION TO EXTEND STAY OF PROCEEDINGS**

NOW COMES Rain CII Carbon LLC (“Rain Carbon”), by and through its attorneys, ArentFox Schiff LLP, and pursuant to 35 Ill. Adm. Code § 101.502 and 101.514, provides this Status Report and Unopposed Motion to Extend Stay of Proceedings for six months, up to and including April 29, 2026.

1. On September 5, 2023, the Illinois Environmental Protection Agency (“IEPA”) filed a Motion for Stay of Proceedings, or in the Alternative, Motion for Extension of Time to File Recommendation while the Illinois Pollution Control Board (the “Board”) considered Rain Carbon’s substantively similar rulemaking proposal in R23-18(A). On October 5, 2023, the Board granted IEPA’s motion to stay the proceedings for 90 days, until December 27, 2023. *See* Order of the Board, PCB No. AS 24-05 at 1. On January 4, 2024, the Board granted IEPA’s unopposed motion to extend the stay until April 25, 2024. *See* Hearing Officer Order, PCB No. AS 24-05. Pursuant to 35 Ill. Adm. Code § 101.514, the Board directed the parties to file a status and any additional requests for stay of the proceedings at the close of stay. *Id.*

2. On April 10, 2024, IEPA filed a Status Report and Motion to Extend Stay of Proceedings (“IEPA Status Report”) and requested that the Board extend the stay of proceedings “for 150 days up to and including September 23, 2024 (or a later date if deemed more appropriate by the Board).” IEPA Status Report at 6. On April 11, 2024, Rain Carbon filed its own status report confirming IEPA’s recitation of the status of the matter in the IEPA Status Report and stating no

objection to IEPA's request to extend the stay of proceedings. Rain Carbon's Status Report at 5. On April 15, 2024, the Board granted IEPA's motion and extended the stay until September 23, 2024. *See* Hearing Officer Order, PCB No. AS 24-05. On September 20, 2024, Rain Carbon moved for the Board to extend the stay until November 4, 2024. *See* Status Report and Motion to Extend Stay of Proceedings, PCB No. AS 24-05. On September 23, 2024, the Board granted Rain Carbon's motion and extended the stay until November 4, 2024. *See* Hearing Officer Order, PCB No. AS 24-05.

3. On August 22, 2024, the Board issued a final order in docket number R23-018(A), which adopted Rain Carbon's proposal and directed the Clerk to submit the adopted rules for publication in the Illinois Register. Opinion and Order of the Board, PCB No. R23-18(A) (Aug. 22, 2024). The adopted rules were published in the *Illinois Register* on September 13, 2024. 48 Ill. Reg. 13539, 13711 (Sept. 13, 2024). The rules will be submitted to USEPA for approval as revisions to the Illinois State Implementation Plan ("SIP"). *See* IEPA Post-Hearing Comment, PCB No. R23-18(A), P.C. #23, at p. 7 (May 22, 2024).

4. On November 4, 2024, Rain Carbon filed a Status Report and Motion to Extend Stay of Proceedings. It requested that the Board extend the stay of this proceeding for six months, up to and including May 5, 2025. The Hearing Officer granted Rain Carbon's motion on November 6, 2025, extending the stay of the proceeding to May 5, 2025.

5. On May 1, 2025, Rain Carbon filed its Status Report and Unopposed Motion to Extend Stay of Proceedings. It requested that the Board extend the stay of this proceeding for six months, up to and including November 3, 2025. The Hearing Officer granted Rain Carbon's motion on May 1, 2025, extending the stay of the proceeding to November 3, 2025.

6. On October 1, 2025, IEPA posted on its website a public notice of the adopted rule amendments and the supporting documentation. See IEPA, Public Notice (posted Oct. 1, 2025), <https://epa.illinois.gov/content/dam/soi/en/web/epa/public-notice/documents/general-notices/2025/public-notice-of-sip-submittal-r23-18a.pdf>. The stated purpose of the notice is to solicit public comment on the proposed SIP submittal to USEPA. The comment period remains open through October 31, 2025. After considering public comments, IEPA is expected to submit the adopted amendments and supporting documentation to USEPA for review and approval as a SIP revision. That process will likely take several more months.

Request to Extend Stay

7. Rain Carbon requests that the stay in this proceeding be extended for six months to allow Rain Carbon the ability to pursue its Petition for Adjusted Standard if USEPA were to ultimately disapprove, partially approve or disapprove, or conditionally approve the rule amendments applicable to Rain Carbon as a revision to the Illinois SIP. Once USEPA formally takes action on the amendments adopted by the Board in R23-18(A), Rain Carbon will be able to discern whether the relief sought in this proceeding is needed. At the end of the requested six-month stay extension, Rain Carbon will provide the Board with an update on the status of the SIP approval process and request a further stay if necessary.

8. Rain Carbon discussed this request with counsel for IEPA, and IEPA has no objection to the requested six-month extension of the stay of proceedings.

9. WHEREFORE, for the reasons set forth above, Rain Carbon requests that the Board grant this unopposed Motion to Extend Stay of Proceedings for six months, up to and including April 29, 2026 (or such other date deemed more appropriate by the Board).
