### PETITION FOR REVIEW OF AGENCY LUST DECISION

NOW COMES Petitioner, SIX M CORPORATION, INC., pursuant to Section 57.8(I) of the Illinois Environmental Protection Act, 415 ILCS 5/57.8(I), hereby appeals the Illinois Environmental Protection Agency's failure to notify Petitioner of its final decision within 180 days of submission of an application for payment, stating as follows:

- Petitioner is the former owner of a self-service station in Farmer City, DeWitt County, Illinois, which had been assigned LPC #0390150003.
- 2. On March 8, 2006, Petitioner reported releases from all three underground storage tanks at the facility. Incident Number 2006-0291 was assigned to the releases.
  - 3. On July 13, 2006, all tanks were removed as part of early action activities.
- 4. Further remediation of the releases was delayed by a neighboring property owner's refusal to provide access for investigation and remediation. On August 25, 2011, the Attorney General filed an enforcement action before the Board. People v. Six M Corporation, PCB 2012-035. Neighboring property owner, James McIlvain, was joined as in interested party.
- 5. Thereafter, Petitioner entered into a series of agreements to resolve disputes with the neighboring property owner, in which *inter alia*, Petitioner paid \$15,750.00 to McIlvain for access and property damage.

- 6. On May 6, 2022, Petitioner's attorney submitted a Request for Indemnification pursuant to Section 57.8(a) of the Act (415 ILCS 5/57.8(a)), seeking payment of the \$15,750.00 that Petitioner paid to a third party. A true and correct copy of the cover letter is attached hereto as Exhibit A.
- 7. On January 24, 2023, the Attorney General filed a Stipulation and Proposal for Settlement with the Board in the enforcement action. Among other things, the Stipulation recognized Petitioner's compliance activities to date included negotiating "access to the Mcilvain property to perform the approved remedial activity."
- 8. On April 6, 2023, the Board accepted the stipulation and proposal for settlement in the enforcement action.
- 9. The Underground Storage Tank Fund was created to pay both corrective action and indemnification (415 ILCS 5/57.11(a)(5)), each subject to a separate limit of \$1.5 million per occurrence. (415 ILCS 5/57.8(g))
- 10. Requests for payment of indemnification are made pursuant to Section 57.8(a) of the LUST Program, which governs all applications for payment. (415 ILCS 5/57.8(a) & (c)) The Request for Indemnification was made using Agency forms for applications for payment from the UST Fund.
- 11. The Request for Indemnification was received by the Agency on May 11, 2022.

  See Exhibit B (screenshot from Agency website taken November 4, 2025).
- 12. "If the Agency fails to approve the payment application within 120 days, such application shall be deemed approved by operation of law and the Agency shall proceed to reimburse the owner or operator the amount requested in the payment application." (415 ILCS

5/57.8(a)(1)); see also 35 Ill. Adm. Code § 734.610(d)) (similar))

13. Petitioner has not received any notice of the Agency's final action on the

application for payment, nor has Petitioner given any waiver of the decision deadline. Therefore,

the application is deemed approved by operation of law. (415 ILCS 5/57.8)(a)(1))

14. Petitioner has incurred, and continues to incur, legal costs seeking payment from

the UST Fund for costs of indemnification, which the Board may authorize payment from the

UST Fund pursuant to Section 57.8(1) of the Act. (415 ILCS 5/57.8(1))

WHEREFORE, Petitioner, SIX M CORPORATION prays that: (a) the Agency produce

the Record; (b) a hearing be held; (c) the Board deem the application approved by operation of

law and direct the Agency to pay Petitioner \$15,750.00, plus legal costs for seeking payment

from the UST Fund, and (d) the Board grant Petitioner such other and further relief as it deems

meet and just.


