NOTICE OF DOCUMENTATION RECEIVED REGARDING ADMINISTRATIVE CITATION

NOW COMES the Complainant, the Illinois Environmental Protection Agency ("Illinois EPA"), by and through its attorney, Special Assistant Attorney General Michelle M. Ryan, and respectfully states as follows:

- (1) On October 20, 2025, Illinois EPA served an Administrative Citation on Respondent Randy W. Johnson ("Respondent").
- (2) On November 13, 2025, Illinois EPA received a letter from Respondent (dated November 5 and postmarked November 6, 2025), purporting to be a petition for review contesting this Administrative Citation. Exhibit A.
- (3) The proof of service filed by Illinois EPA on November 3, 2025, contained a deadline of December 12, 2025 for the filing of a Petition for Review. This stated deadline was substantially incorrect, because 35 days from the October 20 date of service is November 24, 2025.
- (4) Because it took seven days for the mail to deliver Respondent's letter from Mt. Vernon to Springfield, Illinois EPA is not confident that an attempt to explain to Respondent that his Petition for Review was filed with the wrong governmental agency will result in a timely filing to the Board by the correct deadline of November 24, 2025.

(5) Illinois EPA accepts responsibility for the incorrect deadline in the proof of service sent to Respondent. In order to afford Respondent an adequate opportunity to address this Administrative Citation, Illinois EPA has no objection to the Board considering the documentation sent to Illinois EPA as having been timely filed with the Board in this matter.

WHEREFORE, the Illinois Environmental Protection Agency requests that the Board take whatever action it deems appropriate in this situation.
