Good afternoon,

The Board plans to pursue an expedited correction of the background text errors you highlighted this morning in Part 722. Those errors stem from the Board's IIS rulemaking docket R24-12. Again, we apologize for inadvertently omitting some Part 722 amendments from Code pages filed at final adoption in 2024.

Thank you for agreeing to tell SOS that the Board wishes to temporarily withdraw its pending submittal for Register publication of proposed amendments to Part 722. The Board proposed these amendments by order of April 16, 2026, in its IIS rulemaking docket R25-12. As you indicate, once the expedited correction is complete, we will resubmit the proposed Part 722 amendments to SOS for publication but with the corrected background text.

Subject: [External] Expedited correction process

Hi Richard,

An expedited correction is a two-step process. During the first step, you'll submit a request for correction to us by email. We don't have a specific template for the request for correction, but it should contain all the items listed in [1 Ill. Adm. Code 245.110\(c\)](#). Then, JCAR will consider the request. If JCAR certifies the request, you will publish a notice of correction in the Register and file it with SOS, much like for an adopted rule. The effective date would be the appropriate 2024 date and the text that should've been included all along will be included as background text.

However, you would need to complete the expedited correction *before* adopting the affected currently-pending IIS rules, since we and SOS can't knowingly allow incorrect background text to be adopted. If you decide to pursue an expedited correction, you will need to withdraw the relevant currently-pending IIS rules from publication in the Register. If you go this route, we need to know which items are being withdrawn by the end of business today. To be clear, they won't be permanently withdrawn, you'll just wait to publish and adopt them until after the expedited correction has taken effect.

The other option is replacement pages. As we discussed, replacement pages would allow you to move ahead with publication, but the changes that should've been adopted in 2024 would need to be incorporated into the current rulemaking as new changes with strikes and underlines, and I'm not sure whether or not you could have a 2024 effective date on these changes.

I know we spoke on the phone, but please confirm for me in writing which option you intend to take before 4:30pm today so that we can make any necessary changes to this week's Register publication.
