MOTION FOR AN EXTENSION OF TIME TO FILE THE RECORD

NOW COMES Respondent, the Illinois Environmental Protection Agency, by and through its attorney, KWAME RAOUL, Attorney General of the State of Illinois, and hereby moves for an extension of time to file the administrative record in this matter pursuant to Sections 101.522 and 105.116 of the Board’s Procedural Rules, 35 Ill. Adm. Code 101.522 and 105.116. In support thereof, Respondent states as follows:

1. On July 6, 2026, The Premcor Refining Group, Inc. (“Petitioner”) filed a Petition for Review of Final Decision.
2. Pursuant to Section 105.116(a) of the Board’s regulations, 35 Ill. Adm. Code 105.116(a), Illinois EPA (“Respondent”) must file the administrative record by August 5, 2026.
3. Counsel for Respondent is currently reviewing and preparing the record but anticipates that additional time will be required to file the record prior to the deadline on August 5, 2026.
4. Counsel for Respondent has conferred with Counsel for Petitioner regarding this request for an extension, and Counsel for Petitioner indicated that they have no objections to an extension.

5. A telephonic status conference regarding this matter is scheduled for August 10, 2026 at 10:00 a.m.
