ORDER OF THE BOARD (by C. A. Manning):


On November 18, 1993, the Board entered a default order in **this matter, which was initiated by the Agency's filing of an administrative citation with the Board on October 1, 1993. On December 3, 1993, respondents filed a "petition for review" of the administrative citation, which they state is "file stamped received in the State of Illinois Pollution Control Board October 1, 1993 which was not served upon the Respondents until recently".**

The Board notes that, by filing dated October 8, 1993, the Agency provided a copy of the certified mail receipt card (copy attached), as it is required to do by Section 31.1(c) of the Act. The card was signed by "Pam Carter" indicating that delivery of the administrative citation was made on September 30, 1993 to Raymond and Pamela S. Carter at 203 Union St., Staunton, IL 62088.

Any petition for review was accordingly required to be filed on or before November 4, 1993 as provided in Section 31.1(d)(1) of the Act. **This petition for review is accordingly dismissed as untimely filed. The Board's November 18, 1993 default order continues in effect.**

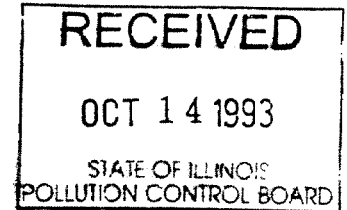
