OPINION AND ORDER OF THE BOARD (by J. Marlin):

This matter comes before the Board on a December 2, 1985 complaint filed by the Illinois Environmental Protection Agency against Continental Grain Company (Continental). The Complaint alleges that Continental at its Spring Valley, IL grain loading facility caused, threatened, or allowed violations of Section 9(a) of the Illinois Environmental Protection Act (Act) and 35 Ill. Adm. Code 212.462(c)(3)(A) and 212.462(e) beginning at least on July 1, 1983 and continuing up to the filing of the Complaint. The Complaint also alleges violation of Section 9(b) of the Act and 35 Ill. Adm. Code Section 201.144 since at least April 4, 1983 and continuing until the filing of the Complaint.

Hearing on this matter was held on June 23, 1987 in Princeton, IL. At hearing, the parties submitted a Stipulation and Proposal for Settlement (Stipulation). The Stipulation is attached and adequately addresses the facts in this matter. Accordingly, this opinion will not contain the customary discussion of the issues.

The Board notes, though, that according to the Stipulation, Continental "is not admitting its liability for violations alleged in the Complaint". Also, the Stipulation states that Continental has received a permit to operate a barge loading spout tip aspiration system and is currently in compliance with the regulations.

In evaluating this enforcement action and proposed settlement agreement, the Board has taken into consideration all the facts and circumstances in light of the specific criteria delineated in Section 33(c) of the Act and finds the Stipulation and Proposal for Settlement acceptable under 35 Ill. Adm. Code

103.180. Accordingly, the Board orders Continental to comply with the Order set forth herein.

This Opinion and Order constitutes the Board's findings of fact and conclusions of law in this matter.

ORDER

It is the Order of the Illinois Pollution Control Board that:


- 1) The Board hereby accepts the Stipulation and Proposal for Settlement executed by Continental Grain Company and the Illinois Environmental Protection Agency concerning Continental's Spring Valley facility and filed with the Board on July 10, 1987. The Stipulation and the Proposal for Settlement is attached hereto.
- 2) Continental shall, by certified check or money order payable to the State of Illinois and designated for deposit into the Environmental Protection Trust Fund, pay the sum of \$10,000 (Ten Thousand Dollars). The sum shall be paid within 60 days of the date it receives notice of this order. The payment shall be mailed to:

- 3) Continental waives its right to have any unused portion of said payment returned to Continental.
- 4) The terms and conditions of the Stipulation and Proposed Settlement are incorporated into and made a part of this Order.

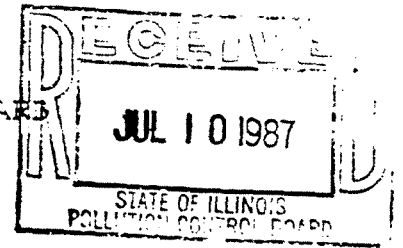
IT IS SO ORDERED.

STIPULATION AND PROPOSAL FOR SETTLEMENT

The parties in the above-styled case, believing that litigation of the matter would be neither in their best interests nor in the best interests of the public, have agreed to a settlement under the terms and conditions set forth below. This Stipulation and Proposal for Settlement is made and agreed upon and submitted to the Illinois Pollution Control Board ("Board") for the purposes of settlement only, upon the condition that the Board approve it in its entirety. The terms of this Stipulation and Proposal for Settlement shall be binding upon the Complainant and Respondent, and their assigns and all successors in interest. In the event that the Board does not approve this Stipulation and Proposal for Settlement in its entirety, it shall be null and void and of no effect in this or any other proceeding. In entering into this Stipulation and Proposal for Settlement, Respondent is not admitting its liability for the violations alleged in the Complaint, nor any of the allegations of fact made in that complaint except as stipulated to below. Further, this

Stipulation and Proposal for Settlement is not to be used for any other purpose or proceeding, is not an admission of wrongdoing on Respondent's part and is not admissible as evidence by any party in any proceeding.

Subject to the foregoing understanding and agreement, the parties stipulate as follows:

1. Continental Grain Company ("Continental"), a Delaware corporation licensed to do business in Illinois, operates a grain loading facility on the Illinois River in Spring Valley, Bureau County, Illinois, at which grain from the surrounding area is loaded into barges.

2. Construction of this facility was commenced prior to April 14, 1972.

3. On June 5, 1978, the Illinois Environmental Protection Agency ("IEPA") issued an operating permit for this facility, said permit to expire April 3, 1983.

4. This permit was issued on the basis that the facility had an annual grain through-put ("AGT") of 5,000,000 bushels.

5. The facility had an AGT for Fiscal Year 1983/1984 of 8,247,167 bushels.

6. Continental, prior to the commencement of this suit, had not installed equipment on the loading spout used to load barges at the facility which was capable of capturing particulate matter emissions generated in the course of loading said barges in an induced air draft stream, which stream was ducted through air pollution control equipment that has a rated and actual particulate removal efficiency of not less than 90% by weight.

7. The operating permit for this facility expired on April 3, 1983.

8. Following expiration of said permit, Continental operated said facility, including barge loading spout equipment.

9. On July 20, 1984, Continental filed a variance petition (PCB 84-97) asking the Board to find that the tip aspiration system requirement contained in 35 Ill. Adm. Code Sec. 212.462(d)(3)(A) was invalid as applied to the Spring Valley facility find that the Spring Valley facility was in compliance with the rule or, in the alternative, to grant Continental a five year variance from the rule.

10. In the meantime, on April 30, 1985, Continental applied for an operating permit for the Spring Valley facility except the barge loading equipment. The IEPA granted this permit on May 31, 1985 (Application No. 7302099, I.D. No. 011809AAB).

11. As of the time this enforcement action was filed, the Spring Valley facility was in compliance with all provisions of Title II of the Environmental Protection Act and the Board's air regulations relating to grain handling operations except those alleged in the complaint. As to these, Continental had, prior to the initiation of this enforcement action, filed the petition for variance described above.

12. As part of an agreement to settle the variance petition and this enforcement action, Continental, on August 16, 1985, filed an application to construct a barge loading spout tip aspiration system and thus bring its barge loading operations

into unquestioned compliance with 35 Ill. Adm. Code Sec. 212.462(d)(3)(A).

13. The IEPA granted this permit on September 6, 1985 (Application No. 85080054, I.D. No. 0110809AAB). On November 11, 1985, the State moved to dismiss Continental's variance petition. The Board, on December 20, 1985, granted the State's motion, over Continental's objection, because it found that installation of the tip aspiration system would bring Continental into compliance with 35 Ill. Adm. Code Sec. 212.462(d)(3) and that, therefore, the variance was unnecessary.

14. Continental installed the tip aspiration system and on March 19, 1986, again applied for renewal of its operating permit. The IEPA issued this permit (Application No. 73020999, I.D. No. 011809AAB) on April 10, 1986.

PROPOSAL FOR SETTLEMENT

Continental agrees to pay \$10,000 to Environmental Protection Trust Fund within 60 days of the date the Board approves this Stipulation and Proposal for Settlement. Said payment shall be made by certified check or money order, payable to the Environmental Protection Trust Fund, and mailed to:

Continental waives its right to have any unused portion of said payment returned to Continental.

WHEREFORE, Complainant and Respondent jointly request that the Board accept and adopt this Stipulation and Proposal for Settlement.
