PROPOSED RULE. FIRST NOTICE.

ORDER OF THE BOARD (by R. C. Flemal):

Today the Board sends the Agency's proposed amendments in this matter to first notice. Certain deadlines imposed by the Clean Air Act require that the Board quickly reach a final disposition of this matter. Moreover, should that disposition be adoption of the proposed amendments, it could quite possibly be required that affected facilities be in compliance by the same December 31, 1987, date. The Board sees this as a very tight timeframe within which the affected facilities might act, particularly given that a number of time-consuming procedural steps are yet to be undertaken before final disposition.

The Board accordingly takes its action today to allow that the activities associated with first notice may proceed concurrently with the final submissions of information and comments which the interested entities are expected to make over the next several weeks. In taking this action the Board believes that whatever the outcome, final disposition of this matter will proceed in as timely a fashion as possible, to the benefit of all concerned. The Board cautions that this action in no way constitutes a determination by the Board on the ultimate merits of the proposed amendments.

ORDER

The Board hereby proposes the following amendments for first notice publication. The Clerk shall cause first notice publication of these proposed amendments in the Illinois Register:

> TITLE 35: ENVIRONMENTAL PROTECTION SUBTITLE B: AIR POLLUTION CHAPTER 1: POLLUTION CONTROL BOARD

SUBPART H: SPECIAL LIMITATIONS FOR SOURCES IN MAJOR URBANIZED AREAS WHICH ARE NONATTAINMENT FOR OZONE a) The limitations of Subpart P shall apply unless the facility's aggregate uncontrolled rotogravure and/or flexographic printing press emissions of volatile organic material are limited by operating permit conditions to 90.7 Mg (100 tons) per year or less in the absence of air pollution control equipment or whose actual emissions in the absence of air pollution control equipment would be less than or equal to 90.7 Mg (100 tons) per year when averaged over the preceding three calendar years.

b) If an owner or operator of a packaging rotogravure printing press proposes to comply with the limitations of Section 215,401 pursuant to subsection (d) of that Section, then the combined capture and control system must provide an overall reduction in volatile organic material emissions of at least 65 percent.
