RESOLUTION AND ORDER OF THE BOARD (by J.D. Dumelle):

This matter comes before the Board upon an April 8, 1987 notice (52 Fed. Reg. 11420) published by the United States Environmental Protection Agency (USEPA) of the promulgation of amendments to the National Standards of Performance for New Stationary Sources (NSPS):

40 CFR 60 Subpart A, K, Ka and Kb Subpart A: General Provisions; and Subpart K: Storage Vessels for Petroleum Liquids (35 Ill. Adm. Code 230.110, 230.210, 230.211 and 230.212)

Pursuant to Section 9.1 of the Environmental Protection Act, the Board is required to adopt amendments "in substance identical" to the federal NSPS amendments. The Board will do so through incorporation by reference of the federal amendments as peremptory amendments. The Board will also update the Code of Federal Regulations reference to the current edition.

ORDER

The Board hereby adopts the following amendments to Title 35: Environmental Protection; Subtitle B: Air Pollution; Chapter I: Pollution Control Board; Part 230: New Source Performance Standards:
