June 26, 2002), accepted a final stipulation and settlement agreement, and ordered the respondent to pay a total civil penalty of \$5,500 and to cease and desist from further violations.	7-0 RCRA-E

<b>PCB 01-135</b>	<u>People of the State of Illinois v. June 26, 2002), and 35 Ill. Adm. Code 812.101(a). The Board ordered the respondent to pay a total civil penalty of \$12,000 and to cease and desist from further violations. Complainant must file an affidavit in support of their request for fees by November 1, 2002, and respondent may file a response to the affidavit by November 15, 2002.	6-1 Marovitz dissented L-E

The Chairman's motion to approve the Calendar Year 2003 Board Meeting Dates was adopted by a vote of 7-0.


