Please be advised that should you wish to discharge to surface waters in the future, you must submit a complete application to this Agency a minimum of 180 days in advance of any discharge.

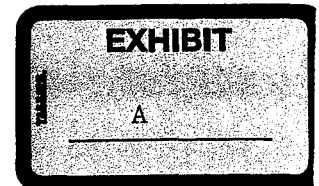


