WAIVER OF STATUTORY DECISION DEADLINE

NOW COMES the Petitioner, DEAN FOODS COMPANY ("Dean Foods"), pursuant to 35 Ill. Admin. Code §101.308(c)(2) and waives the statutory deadline for final Board decision in this permit appeal proceeding as specified in Section 40 of the Illinois Environmental Protection Act (Act), 415 ILCS 5/40. In support of its waiver, Petitioner states:

- 1. On August 21, 2001, Dean Foods filed a Petition for Review of certain conditions contained in the Illinois Environmental Protection Agency's ("IEPA") July 18, 2001 Lifetime Operating Permit. On September 6, 2001, the Board issued an Order accepting the Petition for hearing.
