Thank you very much for your May 11, 2004 letter requesting a determination as to whether the Department of Commerce and Economic Opportunity intends to conduct an economic impact study of the proposed rules in the above-referenced docket.

The Department has reviewed the amendments to the Illinois Dissolved Oxygen Standard (35 Ill. Adm. Code 302.206) that have been proposed by the Illinois Association of Wastewater Agencies. Based on this review, and in light of continued fiscal constraints, the Department has decided not to conduct a study of the economic impact of the proposed rules, pursuant to 415 ILCS 5/27(b).
