JURISDICTION

This Administrative Citation is issued pursuant to the authority vested in the Illinois Environmental Protection Agency by Section 31.1 of the Illinois Environmental Protection Act, 415 ILCS 5/31.1 (2002).

FACTS

1. That Respondent, Knox County Landfill Committee, is the permitted owner and operator of Knox County Landfill #3, a facility located in rural Knox County, near Wataga, Illinois.

2. That Respondent, Greg Ingle, is the Certified Operator of the above-referenced facility.

3. That said facility is operated as a sanitary landfill, operating under Illinois Environmental Protection Agency Permit No. 1994-105-LFM, and is designated with Site Code No. 0958160003. The facility is commonly known to the Illinois Environmental Protection Agency as Knox County Landfill #3.

 That Respondents have owned and/or operated said facility at all times pertinent hereto.

6. That on September 24, 2004, Jeffrey Port of the Illinois Environmental Protection Agency's Peoria Regional Office inspected the above-referenced facility. A copy of his inspection report setting forth the results of said inspection is attached hereto and made a part hereof.

VIOLATIONS

Based upon direct observations made by Jeffrey Port during the course of his September 24, 2004 inspection of the above-referenced facility, the Illinois Environmental Protection Agency has determined that Respondents violated the Illinois Environmental Protection Act (hereinafter, the "Act") as follows:

(1) That Respondents conducted a sanitary landfill in a manner which resulted in uncovered refuse remaining from any previous operating day or at the conclusion of any operating day, a violation of Section 21 (o)(5) of the Act, 415 ILCS 5/21 (o)(5) (2002).

CIVIL PENALTY

Pursuant to Section 42(b)(4) of the Act, 415 ILCS 5/42(b)(4) (2002), Respondents are subject to a civil penalty of Five Hundred Dollars (\$500.00) for each of the violations identified above, for a total of <u>Five Hundred Dollars (\$500.00)</u>. If Respondents elect not to petition the Illinois Pollution Control Board, the statutory civil penalty specified above shall be due and payable no later than December 15, 2004, unless otherwise provided by order of the Illinois Pollution Control Board.

If Respondents elect to contest this Administrative Citation by petitioning the Illinois Pollution Control Board in accordance with Section 31.1 of the Act, 415 ILCS 5/31.1 (2002), and if the Illinois Pollution Control Board issues a finding of violation as alleged herein, after an adjudicatory hearing, Respondents shall be assessed the associated hearing costs incurred by the Illinois Environmental

Protection Agency and the Illinois Pollution Control Board. Those hearing costs shall be assessed in addition to the statutory civil penalty.

Pursuant to Section 31.1(d)(1) of the Act, 415 ILCS 5/31.1(d)(1) (2002), if Respondents fail to petition or elect not to petition the Illinois Pollution Control Board for review of this Administrative Citation within thirty-five (35) days of the date of service, the Illinois Pollution Control Board shall adopt a final order, which shall include this Administrative Citation and a finding of violation as alleged herein, and shall impose the statutory civil penalty specified above.

When payment is made, Respondents' check shall be made payable to the Illinois Environmental Protection Trust Fund and mailed to the attention of Fiscal Services, Illinois Environmental Protection Agency, 1021 North Grand Avenue East, P.O. Box 19276, Springfield, Illinois 62794-9276. Along with payment, Respondents shall complete and return the enclosed Remittance Form to ensure proper documentation of payment.

If any civil penalty and/or hearing costs are not paid within the time prescribed by order of the Illinois Pollution Control Board, interest on said penalty and/or hearing costs shall be assessed against the Respondents from the date payment is due up to and including the date that payment is received. The Office of the Illinois Attorney General may be requested to initiate proceedings against Respondents in Circuit Court to collect said penalty and/or hearing costs, plus any interest accrued.

PROCEDURE FOR CONTESTING THIS ADMINISTRATIVE CITATION

Respondents have the right to contest this Administrative Citation pursuant to and in accordance with Section 31.1 of the Act, 415 ILCS 5/31/1 (2002). If Respondents elect to contest this Administrative Citation, then Respondents shall file a signed Petition for Review, including a Notice of Filing, Certificate of Service, and Notice of Appearance, with the Clerk of the Illinois Pollution Control Board, State of Illinois Center, 100 West Randolph, Suite 11-500, Chicago, Illinois 60601. A copy of said Petition for Review shall be filed with the Illinois Environmental Protection Agency's Division of Legal Counsel at 1021 North Grand Avenue East, P.O. Box 19276, Springfield, Illinois 62794-9276. Section 31.1 of the Act provides that any Petition for Review shall be filed within thirty-five (35) days of the date of service of this Administrative Citation or the Illinois Pollution Control Board shall enter a default judgment against the Respondents.

Narrative

On September 24, 2004, I (Jeff Port) performed a Solid Waste Landfill Inspection at the Knox County Landfill #3 located in rural Knox County, near Wataga. The facility is an 814 Subpart C landfill with authorization under Permit #1994-105-LFM issued on September 29, 1994. The most recent modification, #20 was issued on July 2, 2004.

I arrived at the site at 5:08 AM. I was accompanied by Dawn Ingold, DLPC/FOS Peoria. The entrance gate to the facility was locked but the exit gate was open, so we proceeded through the exit gate. Two trucks were leaving the site. I explained to one of the drivers that we were going to perform an inspection at the site. We then went to the office and found that the door was locked. We next proceeded out to the landfill.

We began the inspection at Cell 3. Photographs P1 through P4 were taken in the center of Cell 3. Photographs P5 and P6 were taken on the southwest corner of Cell 3. From Cell 3, we proceeded to Cells 1/2.

Photographs P7 and P8 show uncovered refuse at the southeast corner of Cells 1/2. Photograph P9 shows uncovered refuse on the southern slope of Cells 1/2. Photograph P10 shows uncovered refuse on Cells 1/2. Photographs P11 through P13 show the top of Cells 1/2. Photographs P14 through P16 show uncovered refuse in ruts on the eastern slope of Cells 1/2. After photographing this area we went to Cells 4/5.

Photographs P18 through P20 show uncovered refuse in ruts on the eastern slope of Cells 4/5. Some of these ruts were over one foot wide and up to two feet deep. A variety of waste was seen protruding through the soil in this area. We next proceeded to the newly developed Cell 9.

The facility had begun placing waste in the new cell and had a well-developed footprint here. Photographs P21 through P23 were taken near the southeast corner of Cell 9. Photographs P24 through P27 show uncovered refuse in the previous day's active area of Cell 9. Photographs P28 and P29 show Cell 9 looking toward the east. Photograph P30 shows Cell 9 looking toward the west.

Additional uncovered refuse was observed on Cell 4/5. Photograph P31 shows the uncovered refuse. We next returned to Cell 3. Photograph P32 shows uncovered refuse on the southern slope of Cell 3. We proceeded around to the western slope of Cell 3 and then examined Cells 6/7.

Photographs P33 through P36 show uncovered refuse in ruts on the western slope of Cells 6/7. A variety of waste can be seen in the ruts here. Photographs P37 and P38 show uncovered refuse in ruts on the northern slope of Cells 6/7. After examining and photographing this area, an inspection was performed on Knox County Landfill #2 and the Compost facility. Those inspections are under their own covers.

After completing the other inspections, we went to the office were I reviewed facility records. I examined the load checks and cover reports. These items appeared to be in order. After further discussion with Mr. Ingle, we left the site at 8:40 AM.

Photograph locations are depicted on the accompanying site map. Based upon this inspection, the following violations were found to be continuing and are indicated on the accompany checklist.

Pursuant to Section 21(d)(1) of the {Illinois} Environmental Protection Act (415 ILCS 1. 5/21(d)(1)), no person shall conduct any waste-storage, waste-treatment, or wastedisposal operation without a permit granted by the Agency or in violation of any conditions imposed by such permit.

A violation of Section 21(d)(1) is alleged for the following reasons: Knox County as owner and operator of Knox County Landfill #3 failed to comply with the following conditions of Permit Number 1994-105-LFM.

II. Operating Conditions

- 2. The operator of this solid waste facility shall not conduct the operation in a manner which results in any of the following.
 - Uncovered refuse remaining from any previous operating day or at e. the conclusion of any operating day, unless authorized by permit;
- 2. Pursuant to Section 21(d)(2) of the {Illinois} Environmental Protection Act (415 ILCS 5/21(d)(2)), no person shall conduct any waste-storage, waste-treatment, or wastedisposal operation in violation of any regulations or standards adopted by the Board under this Act.

A violation of Section 21(d)(2) is alleged for the following reason: Knox County, as owner and operator of Knox County Landfill #3, conducted a waste-disposal operation in violation of Section 811.106(a) of the Regulations.

3. Pursuant to Section 21(e) of the {Illinois} Environmental Protection Act (415 ILCS 5/21(e), no person shall dispose, treat, store or abandon any waste, or transport any waste into this State for disposal, treatment, storage or abandonment, except at a site or facility which meets the requirements of this Act and of regulations and standards thereunder.
