JURISDICTION

This Administrative Citation is issued pursuant to the authority vested in the Illinois Environmental Protection Agency by Section 31.1 of the Illinois Environmental Protection Act, 415 ILCS 5/31.1 (2002).

<u>FACTS</u>

1. That Respondent, Knox County Landfill Committee, is the permitted owner and operator of Knox County Landfill #3, a facility located in rural Knox County, near Wataga, Illinois.

2. That Respondent, Greg Ingle, is the Certified Operator of the above-referenced facility.

3. That said facility is operated as a sanitary landfill, operating under Illinois Environmental Protection Agency Permit No. 1994-105-LFM, and is designated with Site Code No. 0958160003. The facility is commonly known to the Illinois Environmental Protection Agency as Knox County Landfill #3.

5. That Respondents have owned and/or operated said facility at all times pertinent hereto.

6. That on January 21, 2005, Jeff Port of the Illinois Environmental Protection Agency's Peoria Regional Office inspected the above-referenced facility. A copy of his inspection report setting forth the results of said inspection is attached hereto and made a part hereof.

VIOLATIONS

Based upon direct observations made by Jeff Port during the course of his January 21, 2005 inspection of the above-referenced facility, the Illinois Environmental Protection Agency has determined that Respondents violated the Illinois Environmental Protection Act (hereinafter, the "Act") as follows:

(1) That Respondents conducted a sanitary landfill in a manner which resulted in uncovered refuse remaining from any previous operating day or at the conclusion of any operating day, a violation of Section 21 (o)(5) of the Act, 415 ILCS 5/21 (o)(5) (2002).

<u>CIVIL PENALTY</u>

Pursuant to Section 42(b)(4) of the Act, 415 ILCS 5/42(b)(4) (2002), Respondents are subject to a civil penalty of Five Hundred Dollars (\$500.00) for each of the violations identified above, for a total of <u>Five Hundred Dollars (\$500.00)</u>. If Respondents elect not to petition the Illinois Pollution Control Board, the statutory civil penalty specified above shall be due and payable no later than <u>April 15, 2005</u>, unless otherwise provided by order of the Illinois Pollution Control Board.

If Respondents elect to contest this Administrative Citation by petitioning the Illinois Pollution Control Board in accordance with Section 31.1 of the Act, 415 ILCS 5/31.1 (2002), and if the Illinois Pollution Control Board issues a finding of violation as alleged herein, after an adjudicatory hearing, Respondents shall be assessed the associated hearing costs incurred by the Illinois Environmental

Protection Agency and the Illinois Pollution Control Board. Those hearing costs shall be assessed in addition to the statutory civil penalty.

Pursuant to Section 31.1(d)(1) of the Act, 415 ILCS 5/31.1(d)(1) (2002), if Respondents fail to petition or elect not to petition the Illinois Pollution Control Board for review of this Administrative Citation within thirty-five (35) days of the date of service, the Illinois Pollution Control Board shall adopt a final order, which shall include this Administrative Citation and a finding of violation as alleged herein, and shall impose the statutory civil penalty specified above.

When payment is made, Respondents' check shall be made payable to the Illinois Environmental Protection Trust Fund and mailed to the attention of Fiscal Services, Illinois Environmental Protection Agency, 1021 North Grand Avenue East, P.O. Box 19276, Springfield, Illinois 62794-9276. Along with payment, Respondents shall complete and return the enclosed Remittance Form to ensure proper documentation of payment.

If any civil penalty and/or hearing costs are not paid within the time prescribed by order of the Illinois Pollution Control Board, interest on said penalty and/or hearing costs shall be assessed against the Respondents from the date payment is due up to and including the date that payment is received. The Office of the Illinois Attorney General may be requested to initiate proceedings against Respondents in Circuit Court to collect said penalty and/or hearing costs, plus any interest accrued.

PROCEDURE FOR CONTESTING THIS ADMINISTRATIVE CITATION

Respondents have the right to contest this Administrative Citation pursuant to and in accordance with Section 31.1 of the Act, 415 ILCS 5/31/1 (2002). If Respondents elect to contest this Administrative Citation, then Respondents shall file a signed Petition for Review, including a Notice of Filing, Certificate of Service, and Notice of Appearance, with the Clerk of the Illinois Pollution Control Board, State of Illinois Center, 100 West Randolph, Suite 11-500, Chicago, Illinois 60601. A copy of said Petition for Review shall be filed with the Illinois Environmental Protection Agency's Division of Legal Counsel at 1021 North Grand Avenue East, P.O. Box 19276, Springfield, Illinois 62794-9276. Section 31.1 of the Act provides that any Petition for Review shall be filed within thirty-five (35) days of the date of service of this Administrative Citation or the Illinois Pollution Control Board shall enter a default judgment against the Respondents.

Narrative

On January 21, 2005, I (Jeff Port) performed a Solid Waste Landfill Inspection at the Knox County Landfill #3 located in rural Knox County, near Wataga. The facility is an 814 Subpart C landfill with authorization under Permit #1994-105-LFM issued on September 29, 1994. The most recent modification, #21 was issued on December 23, 2004.

I arrived at the site at 5:38 AM. The entrance gate to the facility was locked. Photograph P1 shows the locked gate. At approximately 7:35 one of the facility's employees opened the exit gate. I spoke with him briefly and he told me waste was being deposited in the new cell. I then proceeded to the new cell. Photographs P2 through P11 were taken in the new cell. These photographs show uncovered refuse from a previous operating day. Photograph P12 shows the east edge of the site looking toward the south. Photograph P13 shows the east side of the landfill looking toward the southwest. Photograph P14 shows the east side of the landfill looking toward the west. Photographs P15 and P16 were taken at the southeast corner of the landfill. The show the site looking toward the northwest and west respectively. Photographs P17 through P19 were taken at the top of Cells 1/2. They show the site looking toward the west, northwest, and north respectively. Photograph P20 was taken at the bottom center of Cells 1/2. It shows the southern slope of this area. Photograph P21 shows the southern slope looking toward the northeast. Photograph P22 shows the southern slope of Cell 3 looking toward the north. Photographs P23 through P25 were taken at the southwest corner of Cell 3. They show the site looking toward the northeast, northeast, and north respectively. Photograph P26 shows the western slope of Cells 5/6 looking toward the east. Photographs P27 and P28 were taken on the top of Cells 5/6 looking toward the east and south. Photographs P29 and P30 were taken at the north slope of Cells 5/6 they show the site looking toward the southeast and east. Photographs P31 through P33 were taken on the top of Cells 4/5. Photograph locations are depicted on the accompanying site map. Based upon this inspection, the following violations were found to be continuing and are indicated on the accompany checklist.
