ADMINISTRATIVE CITATION

<u>Violation:</u> 415 ILCS 5/21(p)(1) 415 ILCS 5/21(p)(3) <u>Civil Penalty</u>: \$1,500.00 \$1,500.00

<u>Facts</u>

For this Administrative Citation to John and Ella Hall and South Holland Trust No. 10897 the County of Kankakee ("County") states as follows:

- Complainant, County, is a unit of local government to which the Illinois Environmental Protection Agency has delegated authority to issue administrative citations pursuant to Section 4(r) of the Illinois Environmental Protection Act ("Act"), 415 ILCS 5/4(r) (2003). County is thus a "delegated unit" and may issue administrative citations under 35 Ill. Adm. Code 108.200.
- 2. Respondents John and Ella Hall and South Holland Trust #10897, are the owners or beneficial owners (at the time of the May 02, 2005 inspection) of real property located at PIN 05-11-22-400-033, 14805 E. Rte 114, Momence, Illinois.
- 3. On May 02 2005, County inspector Donna Shehane inspected Respondent's property. A copy of her inspection report is attached as Exhibit 1 and made a part of this Administrative Citation.
- 4. Based upon direct observations made by Ms. Shehane during the course of her inspection, the County has determined that Respondent violated the Act as follows:

- a. Respondent caused or allowed the open dumping of waste in a manner resulting in litter, in violation of Section 21(p)(1) of the Act, 415 ILCS 5/21(p)(1)(2003).
- b. Respondent caused or allowed the open dumping of waste in a manner resulting in open burning, in violation of Section 21(p)(3) of the Act, 415 ILCS 5/21(p)(3)(2003).
- 5. Ms. Shehane's affidavit, attesting to her material actions and observations, is attached as Exhibit 2 and made a part of this Administrative Citation.
- 6. Based upon the foregoing facts, under Section 42(b)(4-5) of the Act, 415 ILCS 5/42(b)(4-5)(2003), Respondent is subject to a civil penalty of One Thousand Five Hundred Dollars (\$1,500.00) for each of the two violations identified above, for a total civil penalty of Three Thousand Dollars (\$3,000.00).

Notices and Instructions to Respondent

- 1. You must pay the civil penalty set forth above unless you contest this Administrative Citation. The following paragraphs contain payment instructions and more information about contesting this Administrative Citation.
- 2. To pay the civil penalty (and any other amounts due) send a check or money order, payable to the County, to:

County of Kankakee Planning Department, Solid Waste Division 189 E. Court Street, Suite 200 Kankakee, Illinois 60901

To ensure that you receive timely and proper credit for your payment, complete a Remittance Form (see Exhibit 3, attached) and include it with your payment.

- 3. You may contest this Administrative Citation by filing a Petition for Review, including a Notice of Filing, Certificate of Service, and Appearance, with the Illinois Pollution Control Board ("Board").
- 4. Any Petition for Review must be filed within thirty-five (35) days of the date of service of this Administrative Citation on you. The Board will not review the Administrative Citation if the Petition for Review is not filed within this time.
- 5. The Petition for Review must be filed with: Clerk of the Illinois Pollution Control Board James R. Thompson Center 100 West Randolph Street Suite 11-500 Chicago, Illinois 60601

A copy of the Petition for Review must be served on the County At the following address:

7. If you do not contest this Administrative Citation by filing a petition for review with the Board within the allotted time, the Board will enter an order finding that you committed the violations alleged above and imposing the statutory civil penalty set forth above. See Section 31.1(d) of the Act, 415 ILCS 5/31.1(d)(2003), and 35 Ill. Adm. Code 108.500(a).

- 8. If you contest this Administrative Citation by filing a timely petition for review with the Board, the Board will hold a hearing. The Board's procedural rules have more information on hearings; see 35 Ill. Adm. Code Parts 101 and 108.
- 9. If the Board finds after the hearing that you committed a violation as alleged above, you will be assessed the hearing costs incurred by CDOE and the Board. Hearing costs are assessed in addition to the statutory civil penalty for the violations. If the Board finds after the hearing that you did not commit a violation as alleged above, or that the violation resulted from uncontrollable circumstances, you will not be assessed hearing costs and you will not have to pay a civil penalty.
- 10. If any civil penalty and/or hearing costs are not paid within the time set by the Board in its final order, interest on the amount due will be assessed against you from the date payment is due and including the date that payment is received.
- 11. If any civil penalty and/or hearing costs are not paid within the time set by the Board in its final order, the Office of the Illinois Attorney General and/or the County of Kankakee may initiate court proceedings against you to collect the amount due, plus any interest accrued. In that event you may also be liable for court costs.

General Remarks

We arrived on site at approximately 10:45 am to conduct an inspection of this property. The weather at the time of this inspection was 43 degrees Fahrenheit with WNW winds at 21 mph and overcast skies. Jim Greenstreet, Kankakee County Code Enforcement Officer, and sworn police officer, accompanied me on this inspection, as Mr. Greenstreet is in training to become a certified Illinois EPA-delegated inspector.

Mr. Greenstreet had previously inspected the site on April 29, 2005, three days before we returned to the site together, in his capacity as Kankakee County Code Enforcement Officer. The attached photographs dated April 29, 2005 were taken by Mr. Greenstreet on April 29, 2005 and depict various burned waste materials including metal debris, a bicycle wheel, a trailer with burned wheels, a microwave, bed springs, rubber, aluminum cans, a burned television set, and other miscellaneous debris.

Photo # 1 from the May 2, 2005 inspection, taken toward the east, depicts a waste pile observed on the ground at the site. Waste observed in the pile, which measured approximately 15' x 4' x 4'(127 cubic feet or about 5 cubic yards) included a battery charger, fence/gate, microwave, and metal debris, as well as evidence of open burning of the material (charred debris and ashes on the ground).

Photo # 2 is a closer shot of the waste material observed in photo # 1. Photo # 3 depicts the battery charger on the ground, as well as the fence, microwave, and miscellaneous charred debris. These items are also visible in Mr. Greenstreet's April 29, 2005 photo # 2, 4, and 6.

We left the site at 10:50 am. The South Holland Trust # 10897/John & Ella Hall site was found to be out of compliance at the time of this inspection. Apparent violations observed:

- 1. Section 9(a) of the Illinois Environmental Protection Act: Cause, Threaten, Or Allow Air Pollution in Illinois.






