- (1) This matter was initially filed on August 26, 2004 on behalf of the Illinois EPA by the undersigned attorney. No specific designation of lead counsel was made by Illinois EPA in this proceeding. Pursuant to 35 Ill. Adm. Code 101.400(a)(4), the undersigned attorney was designated lead counsel in this matter by operation of rule.
