RESPONDENTS EDWARD PRUIM AND ROBERT PRUIM'S MOTION FOR EXTENSION OF TIME TO FILE MOTION FOR SUMMARY JUDGMENT

Respondents, Edward Pruim and Robert Pruim, by and through their attorneys LaRose & Bosco, Ltd., and pursuant to 35 Ill.Adm. 1.
