RESPONDENTS EDWARD PRUIM AND ROBERT PRUIM'S MOTION FOR EXTENSION OF TIME TO FILE MOTION FOR SUMMARY JUDGMENT

Respondents, Edward Pruim and Robert Pruim, by and through their attorneys LaRose & Bosco, Ltd., and pursuant to 35 Ill. Adm. Code 101.500(d) moves the Hearing Officer Bradley Halloran and/or the Illinois Pollution Control Board for a brief extension of time to file a Motion for Summary Judgment on behalf of respondents in PCB No. 04-207 (Enforcement), and in support thereof, states as follows:

1. On December 15, 2005, Counsel for Respondents Edward Pruim and Robert Pruim were notified that on December 12, 2005, Respondent Robert Pruim underwent emergency open heart surgery which involved a quadruple bypass procedure. As such, he is currently unable to

participate in the preparation of the Motion for Summary Judgment which concerns a twenty count complaint. Based on this unforeseen circumstance, Respondents therefore request an additional short extension until Friday, January 13, 2006 to file their Motion for Summary Judgment.

2. Respondents have previously requested a very short extension from December 14, 2005 until December 23, 2005. This motion, currently pending before Hearing Officer Halloran and/or the Pollution Control Board, was unopposed by the Complainant, People of the State of Illinois.

3. Granting this short extension to Respondents under this circumstance will not result in a continuation of the hearing date previously scheduled for April 10-13, 2006, and will not cause any prejudice to Complainant.

WHEREFORE, Respondents respectfully request that the Board and/or Hearing Officer Bradley Halloran enter an order GRANTING their Motion for an Extension of Time to File its Motion for Summary Judgment and allow Respondents a short extension until on or before January 13, 2006 to file their above-referenced motion.


