

Peoria Disposal Company (PDC) is submitting the attached Pollution Control Facility Siting Application to expand the PDC No. 1 Landfill. A check for the \$50,000.00 siting application fee is enclosed. The application provides the information required by Chapter 7.5 Article II of the Peoria County Code and the Illinois Environmental Protection Act (415 ILCS 5/39).

In accordance with the Peoria County Code, 37 copies of the siting application are submitted. These include 35 copies for Peoria County and one copy for each of the two municipalities within one and one-half (1-1/2) miles of the proposed facility (i.e. City of Peoria and City of West Peoria). As previously agreed, one paper copy of Exhibit A to the application (Permit Applications and Related Correspondence with U. S. EPA and Illinois EPA), which comprises 43 boxes of documents, is provided. An electronic copy (pdf file format) of Exhibit A is included with each application copy. Furthermore, eight of the application copy sets include a full paper copy of all application appendices. Electronic copies of the appendices are provided in the remaining application copy sets. The following provides a summary of the attachments:

• Copy Nos. 1 through 8 – seven binders, each with a paper copy of the text and all appendices, and an electronic copy of Exhibit A. The original signature by PDC's principal executive officer is provided in Copy No. 1. In addition, an electronic copy of the full application text and appendices is provided on a CD in the front pocket of Copy No. 1, Volume 1.







