
HEARING OFFICER ORDER

On November 9, 2006, all parties, including the parties in the related PCB 05-212, PCB 05-213, and PCB 05-217 cases, participated in a telephonic status conference with the hearing officer. Respondent’s motions and *motion-in-limine*, filed October 17, 2006, were discussed. Complainant represented that he will not file a response. The parties were advised that respondent’s motions will be taken under advisement and will be ruled upon prior to the next telephonic conference.

It was agreed that the hearing in this matter will be held on December 18, 19 and 20, 2006, consecutive to PCB 05-213. The hearing in the above-captioned matter will commence upon completion of PCB 05-213. The time and location of the hearing will be noted in the notice of hearing.

The parties or their legal representatives are directed to participate in a telephonic pre-hearing conference with the hearing officer on December 7, 2006, at 12:00 p.m. The telephonic status conference must be initiated by the complainant but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




