

HEARING OFFICER ORDER

A telephonic status conference was scheduled for January 25, 2007. The petitioner informed the hearing officer that she had a scheduling conflict and would not be able to appear. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing. If, however, a motion to voluntarily dismiss is filed prior to the next status conference, the conference will be cancelled without further order.

IT IS SO ORDERED.




