HEARING OFFICER ORDER


On February 8, 2007, a telephonic status conference was held. The evaluation of Edward Pruum’s medical condition by his attending cardiologist was discussed. The evaluation was filed by the respondent Community Landfill Company, Inc. (CLC), on January 31, 2007. None of the parties had any objection to the findings represented in the evaluation.

The complainant represented that it intends to file a motion to schedule a hearing and a motion to sever in the future.

CLC was directed to attain a re-evaluation of Edward Pruum from the treating physicians and file them with the Board on or before April 13, 2007. The re-evaluation must address Edward Pruum’s physical ability to partake in a hearing.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on April 19, 2007, at 11:00 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter.

IT IS SO ORDERED.




