- I am employed by the Illinois Environmental Protection Agency ("Illinois EPA"), as
 Assistant Counsel for the Bureau of Land.
- 2. As part of my duties, I am responsible for the preparation of Administrative Citations issued by the Illinois EPA and the negotiation and litigation of appeals filed pursuant to such Administrative Citations. As part of my job experience, I have also submitted travel vouchers for reimbursement.
- 3. I have reviewed the Illinois EPA Division of Legal Counsel File 686-04-AC, which relates to AC 05-47, *Illinois EPA v. Stacy Hess*, for the purpose of determining the costs expended by Illinois EPA.
- 4. I was the Illinois EPA attorney assigned to handle the hearing for AC 05-47, which was held in Pekin. I was required to travel from Springfield to Pekin and back for the hearing.
