

On March 22, 2007, all parties participated in a telephonic status conference with the hearing officer. The petitioner represented that it will file a 90-day waiver of the statutory decision deadline.

At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




