OPINION AND ORDER OF THE BOARD (by G.T. Girard):

On March 22, 2007, the Illinois Environmental Protection Agency (Agency) timely filed an administrative citation against Herman F. Meyers and Karen Meyers (respondents). *See* 415 ILCS 5/31.1(c) (2004); 35 Ill. Adm. Code 108.202(c). The administrative citation concerns a site commonly known as Belknap/Meyers, Herman with Site Code No. 1278015003, and located at 5328 Stanton Ridge Road in Belknap, Massac County. For the reasons below, the Board finds that respondents violated the Environmental Protection Act (Act) (415 ILCS 5 (2004)) and orders respondents to pay \$6,000 in civil penalties.

Under the Act, an administrative citation is an expedited enforcement action brought before the Board seeking civil penalties that are fixed by statute. Administrative citations may be filed only by the Agency or, if the Agency has delegated the authority, by a unit of local government, and only for limited types of alleged violations at sanitary landfills or unpermitted open dumps. *See* 415 ILCS 5/3.305, 3.445, 21(o), (p), 31.1(c), 42(b)(4), (4-5) (2004); 35 Ill. Adm. Code 108.

In this case, the Agency alleges that respondents violated Section 21(p)(1), (p)(3), (p)(4), and (p)(7) of the Act (415 ILCS 5/21(p)(1), (p)(3), (p)(4), and (p)(7) (2004)) by operating an open dump resulting in: (1) litter; (2) open burning; (3) deposition of waste in standing or flowing water; and (4) deposition of general construction or demolition debris or clean construction or demolition debris. The Agency asks the Board to impose a \$6000 civil penalty on respondents. As required, the Agency served the administrative citation on respondents within "60 days after the date of the observed violation." 415 ILCS 5/31.1(b) (2004); *see also* 35 Ill. Adm. Code 108.202(b).

To contest an administrative citation, a respondent must file a petition with the Board no later than 35 days after being served with the administrative citation. If a respondent fails to do so, the Board must find that the respondent committed the violation alleged and impose the corresponding civil penalty. *See* 415 ILCS 31.1(d)(1) (2004); 35 Ill. Adm. Code 108.204(b), 108.406. Here, any petition for review was due on April 25, 2007. Respondents failed to timely

file a petition. Accordingly, the Board finds that respondents violated Section 21(p)(1), (p)(3), (p)(4), and (p)(7) of the Act (415 ILCS 5/21(p)(1), (p)(3), (p)(4), and (p)(7) (2004)).

The civil penalty for violating Section 21(p) is \$1500 for each violation. 415 ILCS 5/42(b)(4) (2004); 35 III. Adm. Code 108.500(a). Because there are four violations, the total civil penalty is \$6000. Under Section 31.1(d)(1) of the Act, the Board attaches the administrative citation and makes it part of the order below.

This opinion constitutes the Board's finding of fact and conclusions of law.

<u>ORDER</u>

- 1. Respondents must pay a civil penalty of \$6000 no later than June 18, 2007, which is the first business day following the 30th day after the date of this order.
- 2. Respondents must pay the civil penalty by certified check or money order, made payable to the Illinois Environmental Protection Trust Fund.
- 3. Respondents must send the certified check or money order and the remittance form to:

- 4. Penalties unpaid within the time prescribed will accrue interest under Section 42(g) of the Environmental Protection Act (415 ILCS 5/42(g) (2004)) at the rate set forth in Section 1003(a) of the Illinois Income Tax Act (35 ILCS 5/1003(a) (2004)).
- 5. Payment of this penalty does not prevent future prosecution if the violations continue.

IT IS SO ORDERED.

Section 41(a) of the Environmental Protection Act provides that final Board orders may be appealed directly to the Illinois Appellate Court within 35 days after the Board serves the order. 415 ILCS 5/41(a) (2004); *see also* 35 Ill. Adm. Code 101.300(d)(2), 101.906, 102.706. Illinois Supreme Court Rule 335 establishes filing requirements that apply when the Illinois Appellate Court, by statute, directly reviews administrative orders. 172 Ill. 2d R. 335. The Board's procedural rules provide that motions for the Board to reconsider or modify its final orders may be filed with the Board within 35 days after the order is received. 35 Ill. Adm. Code 101.520; *see also* 35 Ill. Adm. Code 101.902, 102.700, 102.702.
