In re: Comments on the Final Order in R07-2 and R07-11

Dear Mr. McCambridge:

After reviewing the final Order some errors and omissions were discovered. I know that the docket is closed in this matter. If it is too late to make these corrections in this docket, I request that the corrections be made in the next Safe Drinking Water rulemaking.

Please note the following corrections:

- 1) Page 74, Section 611.381 (a), change to read as follows:

A supplier must use only the analytical methods specified in this Section or their equivalents as approved by the USEPA Agency to demonstrate compliance with the...

Reason: This will be consistent with the federal regulation [141.131(a)(1)] since only USEPA is allowed to approve an equivalent laboratory method.

- 2) Page 141-142, Section 611.920 (c) (1): Need to insert 141.600(c)(1) item (v) from the table following the header “Other systems that are part of a combined distribution system”. (excerpt from 71 *FR* 484, Wednesday, January 4, 2006). This should be inserted as 611.920(c)(1)(E) and written to conform to the format used for (A) – (D). Present items (E), (F) and (G) should be changed to (F), (G) and (H).

Reason: This part of the federal regulation is missing from the Board regulations.

- 3) Page 17, Section 611.101 “Initial distribution system evaluation” or “IDSE”:

The last line should read “...Subpart I **not** Subpart X”

Reason: Subpart X of the Board rules pertains to Enhanced Filtration and Subpart I pertains to Disinfectant Residuals, Disinfection Byproducts and Disinfection Byproduct Precursors and equates to Part 141, Subpart L as noted in 141.601(b)(2).

- 4) Change BOARD NOTE to read “Derived from 40 CFR 141.601(b) 611.601(e) (2006).”

Reason: Provides the correct federal rule cite.

- 5) Page 107, Section 611.801 (b), line 3, change to read:
“...within the WHPAs and evaluations of of ~~or~~ the...”

Reason: Typographical error correction.
