**NOTICE OF WAIVER OF 120-DAY  
DECISION DEADLINE FOR AN ADDITIONAL 60 DAYS**

NOW COMES Petitioner, LONE STAR INDUSTRIES, INC., d/b/a Buzzi Unicem USA (hereinafter "Petitioner"), by and through its attorneys, HODGE DWYER ZEMAN, pursuant to 35 Ill. Admin. Code § 101.308(c)(2), and hereby agrees to waive the statutory 120-day decision deadline for final action by the Illinois Pollution Control Board in this proceeding for an additional 60 days, or until May 9, 2008. In support of this Notice, Petitioner states as follows:

1. On May 15, 2007, Petitioner filed a Petition for Review of the construction permit issued to Petitioner by the Illinois Environmental Protection Agency on April 6, 2007.
2. On October 3, 2007, Petitioner filed its second Notice of Waiver of 120-Day Decision Deadline in this matter. The current statutory deadline for this matter is March 10, 2008.
3. Petitioner hereby voluntarily agrees to waive the statutory 120-day decision deadline, for an additional 60 days, or until May 9, 2008, in order to conduct settlement negotiations in this matter.

WHEREFORE, Petitioner, LONE STAR INDUSTRIES, INC., d/b/a Buzzi Unicem USA, prays that the Illinois Pollution Control Board accept this waiver of the statutory 120-day decision deadline for an additional 60 days for final action on Petitioner's appeal of the construction permit issued to it by the Illinois Environmental Protection Agency.
