

HEARING OFFICER ORDER

On January 17, 2008, all parties participated in a telephonic status conference with the hearing officer. The respondent represented that it anticipates that a draft re-newel permit application will be reviewed internally within the next 30 to 60 days. The draft will then be forwarded to the petitioner for its review. The petitioner represented that it will file an additional 60-day waiver of the statutory decision deadline.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on March 13, 2008, at 9:30 a.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




