#### ADMINISTRATIVE CITATION

Violation: 415 ILCS 5/21(p)(1) Civil Penalty \$1,500.00 TOTAL: \$1,500.00

#### JURISDICTION

This Administrative Citation is issued pursuant to authority vested in the Illinois Environmental Protection Agency by 415 JLCS 5/1 et. seq. (1996), specifically 415 ILCS 5/31.1.

#### FACTS

- Complainant, County of DuPage, is a unit of local government to which the Illinois
   Environmental Protection Agency has delegated authority to issue administrative citations
   pursuant to Section 4(r) of the Illinois Environmental Protection Act, ("Act"), 415 ILCS 5/4(r)
   (2007). DuPage County is thus a "delegated unit" and may issue administrative citations under
   35 III, Adm. Code 108.200.
- The Respondent, Margarito Sotelo, is the present occupant and in control and possession of the property at 31W152 Lee Road. West Chicago, located in the County of DuPage, State of Illinois.

- 3. The property is an open dump, operating without an Illinois Environmental Protection Agency Operating Permit, and designated with the Site Code #0438075018. The facility is known to the County as the Margarito Sotelo site.
- 4 The Respondent has occupied, controlled and/or operated the facility at all relevant times hereto.
- 5. On December 3, 2007. Joy Hinz, Field Inspector for DuPage County as delegated by the Illinois Environmental Protection Agency, inspected the property. A true and correct copy of the inspection report, along with Ms. Hinz's affidavit, are attached hereto and made a part hereof.
- 6 Based upon direct observations made by Ms. Hinz during the course of her inspection, DuPage County has determined that Respondent violated the Act as follows:
  - a. Respondent caused or allowed the open dumping of waste in a manner resulting in litter, in violation of Section 21(p)(1) of the Act, 415 ILCS 5/21(p)(1) (2007).
- 7. Based upon the foregoing facts, under Section 42(b)(4-5) of the Act, 415 ILCS 5/42(b)(4-5), Respondent is subject to a civil penalty of One Thousand Five Hundred Dollars (\$1,500.00) for each of the violations identified above, for a total civil penalty of One Thousand Five Hundred Dollars (\$1,500.00).

## Notices and Instructions to Respondent

- You must pay the civil penalty set forth above unless you contest this Administrative Citation. The following paragraphs contain payment instructions and more information about contesting this Administrative Citation.
- To pay the civil penalty (and any other amounts due) send two (2) checks or money orders with the attached Remittance Form, one check in the amount of Seven Hundred and Fifty Dollars payable to DuPage County and the second

check or money order in the amount of Seven Hundred and Fifty Dollars payable to the Illinois Environmental Protection Agency to:

To ensure that you receive timely and proper credit for your payment, complete the attached Remittance Form and include it with your payment.

- You may contest this Administrative Citation by filing a Petition for Review, including a Notice of Filing, Certificate of Service, and Appearance with the Illinois Pollution Control Board ("Board").
- Any Petition for Review must be filed within thirty-five (35) days of the date
  of service of this Administrative Citation on you. The Board will not review
  the Administrative Citation if the Petition for Review is not filed within this
  time.

- If you do not contest this Administrative Citation by filing a petition for review with the Board within the allotted time, the Board will enter an order finding that you committed the violations alleged above imposing the statutory civil penalty set forth above. See Section 31.1(d) of the Act, 415 ILCS 5/31.1(d) and 35 III. Adm. Code 108.500(a).
- 8 If you contest this Administrative Citation by filing a timely petition for review with the Board, the Board will hold a hearing. The Board's procedural rules have more information on hearings; see 35 Ill. Adm. Code Parts 101 and 108.
- 9. If the Board finds after the hearing that you committed a violation as alleged above, you will be assessed the hearing costs incurred by the County of DuPage and the Board. Hearing costs are assessed in addition to the statutory civil penalty for the violations. If the Board finds after the hearing that you did not commit a violation as alleged above, or that the violation resulted from uncontrollable circumstances, you will not be assessed hearing costs and you will not have to pay a civil penalty.
- If any civil penalty and/or hearing costs are not paid within the time set by the Board in its final order, interest on the amount due will be assessed against you from the date payment is due and including the date that payment is received.
- 11. If any civil penalty and/or hearing costs are not paid within the time set by the Board in its final order, the DuPage County State's Attorney's Office may initiate court proceedings against you to collect the amount due, plus any interest accrued. In that event, you may also be hable for court costs.

## Estimated Amount of Waste: 4 cubic yards

#### General Remarks

I conducted this inspection in response to a complaint that waste was being open burned at the site. After arriving, I walked to the house where I attempted to locate an owner. A tenant answered the door. I explained why I was on site. I then walked behind the house where the burn pile was located.

The pile was approximately 6 feet in diameter. It contained bottles, cardboard, furniture, foam cushion, carpet, textiles, aluminum cans, metal, roofing shingles, carpeting and other miscellaneous waste (Photo 1 and Photo 2). The pile of ashes was about one foot in height. The bottles, aluminum cans, metal waste and some of the other debris was partially burned (Photo 3 and Photo 4).

After reviewing the pile, I exited the site.



## Estimated Amount of Waste: 1 cubic yards

#### General Remarks

Pre-Inspection Notes: An Administrative Citation Warning Notice was issued as a result of an inspection completed on September 17, 2007. The Notice cited alleged violations for open dumping and open burning. I received a telephone call from Mr. Sotelo on October 15<sup>th</sup>. He agreed to remove all the waste and ashes.

I conducted this inspection to determine if the site had been cleaned. After arriving, I walked to the house where I met with Mr. Sotelo. I explained that I was on site to see if they had removed all waste and ash remnants from the open burning. I reviewed the area and found that the waste I had previously observed was not on the site. The majority of the ashes had been removed. However, vinyl flooring was now in place in the burn pile.

After inspecting the site, I informed Mr. Sotelo that the vinyl flooring and all ash needed to be removed. I asked that he remove the waste within one week.

I returned to the site on December 20, 2007 and the vinyl flooring was still open dumped on the site. I then exited the site.
