Preliminary Matters

On January 18, 2008, the respondent filed a motion for an extension of time to file the administrative record and a motion to reschedule the hearing. On January 28, 2008, the respondent filed a motion to withdraw its motion for an extension of time to file the administrative record and a motion to withdraw its motion to reschedule the hearing. 
Exhibits


