NOTICE OF PETITION BY BIG RIVER ZINC CORPORATION FOR AN ADJUSTED STANDARD BEFORE THE ILLINOIS **POLLUTION** CONTROL BOARD Big River Zinc Corpo-ration (BRZ), located at Route 3 and Monsanlo Avenue in Sauget, St. Clair County, Illinois, filed a petition for an adjusted standard with the Illinois Pollution Control Board on April 1, 2008 pursuant to 35 III. Adm. Code 720.131(c). That petition, which has been assigned docket #AS-08-009, requests an amendment to its existing adjusted standard ("docket #AS-99-3").
