





**NOTICE OF PETITION
BY BIG RIVER ZINC

Big River Zinc Corporation (BRZ), located at Route 3 and Montsanto Avenue in Sauget, St. Clair County, Illinois, filed a petition for an adjusted standard with the Illinois Pollution Control Board on April 1, 2008 pursuant to 35 Ill. Adm. Code 720.131(c). That petition, which has been assigned docket #AS-08-009, requests an amendment to its existing adjusted standard ("docket #AS-99-3"). Currently, BRZ's existing adjusted standard states that BRZ shall both wash zinc oxide and conduct electrolytic refining at BRZ's refinery in Sauget, Illinois. BRZ requests that its existing adjusted standard be revised to allow BRZ the option of selling the washed zinc oxide to third parties for further refining, or returning the washed zinc oxide to its suppliers for sale to another refiner. Any person may cause a public hearing to be held in the above-described adjusted standard proceeding by filing a hearing request with the Illinois Pollution Control Board within 21 days after the date of the publication of this notice. The hearing request should clearly indicate the docket number for the adjusted standard proceeding, as found in this notice, and shall be mailed to the Clerk of the Board, Illinois Pollution Control Board, 100 W. Randolph Street, Suite 11-500, Chicago, Illinois 60601.


