Under Section 102.108(b) of the Board's procedural rules, "[a]ny person may submit written comments on any proposal within 14 days after the receipt of the hearing transcript in Board offices unless otherwise specified by the hearing officer or the Board." 35 Ill. Adm. Code 102.108(b). Any participant in this proceeding who wishes to file a post-hearing comment with the Board is directed to do so on or before Friday, July 11, 2008. See Tr. 2 at 63-64. Any participant in this proceeding who wishes to file a response to a post-hearing comment with the Board is directed to do so on or before Friday, July 25, 2008. Id.

Comments must be filed with the Board's Clerk and properly served to participants on the Service List for this proceeding. 35 Ill. Adm, Code 102.108(c). Comments and other documents may be filed electronically through the Clerk's Office On-Line (COOL) from the Board's Web site at www.ipcb.state.il.us. In the event that the Board issues a proposal for first notice, the Board's procedural rules provide for an additional period of public comment. See 35 Ill. Adm. Code 102.108(a), 102.604.

Notice List

In an order dated February 13, 2008, the hearing officer stated that the Board would begin this proceeding by including in the Notice List each of approximately 600 potentially affected manufacturers listed in Appendix A to the Technical Support Document filed by the Illinois Environmental Protection Agency (Agency). However, the order stated that the Board would mail copies of subsequent opinions and orders only to those who specifically indicated that they wished to remain on the Notice List.
