HEARING OFFICER ORDER

Depositions of lay or fact witnesses must be completed on or before October 10, 2008. Requests to admit must be served on or before October 31, 2008. Requests for disclosure of expert witnesses must be served on or before October 31, 2008. Written expert witness disclosures must be served on or before December 5, 2008. All dispositive motions must be filed on or before March 20, 2009.

The parties or their legal representatives are directed to participate in a telephonic status conference on September 11, 2008, at 11:30 a.m. The status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing. If, however, a stipulation and proposal for settlement is filed prior to the next status conference, the conference will be cancelled without further notice.
