### **NOTICE OF WAIVER OF 120-DAY DECISION DEADLINE**

Code § 101.308(c)(2), and hereby agrees to waive the statutory 120-day decision deadline for final action by the Illinois Pollution Control Board ("Board") in this proceeding until February 19, 2009.
