
1. On January 13, 2009, a hearing was held in this matter. The hearing transcript was posted on the Board's website on January 23, 2009.
2. Joliet's witnesses completed their review of the hearing transcripts and based on their review of the hearing record, the witnesses noted certain typographical errors that they wish to correct.
3. Joliet respectfully requests the following corrections to the January 13, 2009 hearing transcript:
 - i. Page 23: Line 18- The first word "load" should read "Low"
 - ii. Page 24: Line 3 - The numeral "77" should read "7"

4. Joliet does not believe that the proposed corrections will adversely impact Respondent in this matter. Further, Joliet is filing this motion within 21 days after receipt of the transcript in the Clerk's Office as required under 35 Ill. Adm. Code Section 101.604.


